From Delta Waterfowl:

Annual Breeding Waterfowl Population Survey Estimates 33.99 Million Ducks, Up 5% From 2023

Mallards, wigeon, green-winged teal, and scaup post increases; Pintail bag limit for 2025-2026 season will increase to 3 daily in all flyways

BISMARCK, NORTH DAKOTA

— Duck numbers are up, and
wetland habitat conditions have
improved over important portions
of the key prairie pothole region.

The breeding population of ducks was estimated at 33.99 million, a 5% increase over last year, according to the 2024 Waterfowl Population Status report released today by the U.S. Fish and Wildlife Service. In addition, May pond counts, a key indicator of breeding habitat conditions and potential production, also increased by 4% over the previous spring.

The report details the results from the Waterfowl Breeding Population and Habitat Survey, which has been conducted annually by the USFWS and Canadian Wildlife Service since 1955. The survey is used to set hunting regulations for the following year, so in this case, for the 2025-2026 season. Based on these results, waterfowl hunters

will again enjoy a liberal season framework next season.

"An increased breeding population of ducks and pair counts, along with wetland habitat conditions that improved throughout May and June with good spring rains across most of the prairies, should help boost duck production," said Dr. Frank Rohwer, president and chief scientist for Delta Waterfowl. "We definitely have potential bright spots for duck production in the eastern Dakotas and possibly in Manitoba. The spring rains really helped in those areas, as well as parts of Alberta that started the spring quite dry."

The survey, which was completed in May, estimated 5.16 million total ponds, a 4% increase overall. However, the location of those

ponds differed greatly from 2023. The ponds estimate on the Canadian prairie and parklands, which includes southern regions of Alberta, Saskatchewan, and Manitoba, decreased 19%. Meanwhile, ponds in the United States, including Montana and the Dakotas, increased by 49%.

"The prairies didn't have a good snowpack last winter," said Mike Buxton, waterfowl programs director for Delta Waterfowl.
"Heading into last fall, conditions were OK in the Dakotas, but prairie Canada was dry. Manitoba got decent snow, but not so much in Saskatchewan and Alberta. So, the wetland habitat there started spring in poor condition. That really affects where ducks settle. If the table isn't set

early on, ducks don't stick around to nest. Alberta was really dry, so not many ducks settled there. Saskatchewan was a little bit better."

While the number of total ducks in the Traditional Survey Area increased slightly over 2023, all of the gains were in the far north and west. Just three survey regions (out of eight) posted increases. The Central and Northern Alberta/Northeast British Columbia/Northwest Territories estimated 11.25 million ducks, up 35% and 49% above the longterm average for the region. The Alaska Yukon Territory/Old Crow Flats region showed a 28% increase over 2023, while Northern Saskatchewan/Northern Manitoba/Western Ontario was up 5%. In contrast, duck estimates across the prairie pothole regions were down 10% to 16%, except for the Eastern Dakotas, which was down less than 1% from 2023.

Florida Voters Pass 'Right to Fish and Hunt' Amendment

Unofficial election results show Florida is the latest state to adopt a constitutional amendment to protect hunting and fishing as a wildlife management tool

Preliminary election results show that voters in Florida passed the No. 2 Amendment to "preserve forever" the right to fish and hunt in the state. It's the 24th state to adopt such a resolution, according to the Congressional Sportsmen Foundation, as more wildlife related ballot measures crop up across the U.S. and anti-hunters work to join wildlife commissions.

Ballot measures require 60 percent approval to pass in Florida,

and voters there easily outstripped that margin with 67 percent of voters, or 6.8 million people, casting their ballots to protect hunting and fishing, according to the unofficial results posted Tuesday evening by the Florida Division of Elections. Roughly 33 percent of voters, or 3.3 million people, voted against adopting the amendment. (For comparison, roughly 1.2 million residents bought recreational fishing licenses in 2021, according to the American Sportfishing Association; about 207,000 residents bought hunting licenses that year.) Interestingly this trend bucks the urban-rural divide often seen in wildlife-based ballot measures; every single reporting county was in favor of the amendment, including the large metropolitan areas of Orlando. Tampa, and Jacksonville.

The ballot measure asked Floridians to vote yes or no on the following: Proposing an amendment to the State Constitution to preserve forever fishing and hunting, including by the use of traditional methods, as a public right and preferred means of responsibly managing and controlling fish and wildlife. Specifies that the amendment does not limit the authority granted to the Fish and Wildlife Conservation Commission under Section 9 of Article IV of the State Constitution.

Unsurprisingly, the amendment was vehemently opposed by anti-hunting organizations like the Humane Society of the U.S., who argued that the inclusion of "traditional methods" in the amendment would legalize gill net fishing, which was banned there in the 1990s. This is inaccurate, according to the Florida Fish and Wildlife Commission.

"Both our conservation and legal teams have stated that the current language proposed in Amendment 2 does not change or alter the existing net ban or the ability for it to be enforced. 'Traditional methods' does not undo regulation, nor reset FWC's regulatory authority. Moreover, the net ban is protected by the constitution already. similar to private property rights. Nothing in Amendment 2's language affects these laws," FWC chairman Rodney Barreto said in September. "The FWC maintains regulatory authority over all fish and wildlife in our state. Seasons, bag limits, methods and licensing are still in place and will continue to govern time, place and manner should Amendment 2 pass."

In other words, adopting Amendment 2 won't change any existing fishing regulations or the agency's ability to set seasons, bag limits, or methods, and sportsmen will still have to purchase fishing and hunting licenses.

"A constitutionally-protected right to hunt or fish would make it substantially more difficult for attempts by the state to ban or restrict the hunting or fishing of species of animals," reads a guide to the state's amendments. The measure was placed on the ballot with ready approval in the Florida legislature after it was introduced by state representative Lauren Melo. She referenced hunting and fishing's economic contribution to the state and its role in funding the FWC.

Bag Limit: 6 ducks daily with species restrictions of:

4 mallards (no more than 2 females),3 wood ducks,2 redheads,2 hooded mergansers,

2 canvasbacks.2 black ducks.

1 pintail,2 scaup for first 45 days and 1 scaup for last 15 days,1 mottled duck

Possession Limit: Three times the daily bag or 18 total, varies by species

Snow Geese (White and Blue Phases) and Ross's Geese

Season: Nov. 11 through Feb. 6, 2025

Limits: 20 blue, snow, or Ross's geese daily with no possession limit

White-Fronted Geese

Season: Nov. 11 through Feb. 6, 2025

Limits: 2 daily and 6 in possession

Canada Geese and Brant

Season: Oct. 5-13 and Nov. 11 – Feb. 6, 2025

Limits: 3 Canada geese and Brant in aggregate daily, 9 in possession

Light Goose Conservation Order

Season: Feb. 7 through April 30, 2025

Limits: No daily or possession limits

Hours: One-half hour before sunrise to one-half hour after sunset
