MDC AND GRHA

Inside this month's newsletter you will find a recent notification from MDC in an cooperative agreement with the Great Rivers Habitat Alliance (GRHA). From that notification:

The Missouri Department of Conservation (MDC) and the Great Rivers Habitat Alliance (GRHA) recently entered into a cooperative agreement to protect habitat and add public and educational opportunities on nearly 785 privately-owned acres of prime wetland habitat in St. Charles County previously known as the Whistling Wings Duck Club. The Missouri Conservation Commission formally recognized the new partnership at its Feb. 7 open meeting in Jefferson City.

Now, this cooperative agreement includes \$2 million in financial support from MDC to GRHA of YOUR tax dollars. Looking at GRHA, from their website, https://grha.org/, this looks like an outstanding organization. However, on the surface, and my opinion only, this organization was founded in June 2000 and their directors, well, you just have to see it, go out to the site and take a look. Very impressive I have to say. It appears they have the money to do just about anything. They have only been around since 2000 and get \$2 mill?

Speaking of money, why is the MDC giving them 2 million of our money to them? Granted, in the release it states: "We are thrilled about the creation of a conservation and education partnership with MDC and our shared vision to protect and conserve the property for generations to come," said GRHA President David Bub. "We look forward to developing public-use programs that align with GRHA, and MDC's mission including conservation demonstration, education, research, and hunting. Hunting programs will focus on recruiting new hunters, youth, veterans, women, educators, and first responders." This property will not be a part of MDC's managed waterfowl hunt program. So I question this last quoted statement.

In my mind, simple as it is, should not OUR tax payer dollars be spent in promoting hunting programs where the public DOES see the benefit of THEIR tax payer dollars? For example: How about cleaning up Columbia Bottoms, at least cut down the weeds around the old center. Relook at better management of Columbia bottoms and return it to the jewel of MDC as it once was. How about Marais Temp Claire? Relook at better management of Marais Temp Claire to increase duck population or to attract more ducks Relook at more hunting opportunities for those who pay these taxes, if MDC is going to assist in acquiring new property, at least have it part of managed waterfowl hunts instead of what it appears on the surface, money going to an exclusive private club on the guise of conservation.

AVIAN FLU

MDC encourages public to use caution amidst suspected avian influenza outbreak

The Department is investigating numerous reports of sick and dead waterfowl across Missouri.

JEFFERSON CITY, Mo. -- The Missouri Department of Conservation (MDC) is monitoring reports of sick and dead waterfowl, such as geese and ducks, across the state. The Department is actively collecting birds to determine the cause of illness but suspects highly pathogenic avian influenza (HPAI) to be the cause. Other states, including Kansas and Iowa, are experiencing similar occurrences.

Avian influenza, commonly referred to as bird flu, spreads as birds along the North American flyways intermingle with infected birds from Europe and Asia. The viruses are transmitted from bird to bird through fecal droppings, saliva, and nasal discharges. There is a risk for spillover from wild birds into domestic poultry and then back again from poultry to wild birds, resulting in further spread.

Though HPAI does not present an immediate public health concern, MDC recommends the following:

Do not touch dead geese, waterfowl, or other bird species.

Report any sightings of dead geese to MDC online at http://short.mdc.mo.gov/4KD

Ensure that pets do not come into contact with dead animals to help prevent the spread of disease.

If you have inadvertently come into contact with a dead goose, wash your hands thoroughly and contact a healthcare professional if you experience any unusual symptoms.

Due to ongoing waterfowl hunting seasons, waterfowl hunters should dress game birds in the field whenever possible or at a location away from poultry or other birds. Hunters should also properly dispose of harvest waste by placing the remains in trash bags and disposing of them through trash collection or a permitted landfill. Bald eagles and other raptors are particularly susceptible to avian influenza. This simple action could help prevent bald eagle and other raptor mortalities.

Hunters should also be aware it is possible to transport avian influenza viruses on boats, waders, or other equipment, especially if it isn't dry before moving it from one site to another. Allowing hunting equipment to dry between outings will reduce this chance.

Avian influenza does not present an immediate public health concern, though on rare occasions it has infected humans and other animals. It is safe to eat poultry and wild game as normal cooking temperatures are hot enough to kill the virus if present. Meat should be cooked to an internal temperature of 165 degrees Fahrenheit.

MDC AND GRHA

From an email I received from MDC:

MDC is working with Great River Habitat Alliance to protect and enhance waterfowl opportunities in St. Louis area

New GRHA property in St. Charles will create innovative partnerships in education, research, mentored and special hunts for the public.

JEFFERSON CITY, Mo. – The Missouri Department of Conservation (MDC) and the Great Rivers

Habitat Alliance (GRHA) recently entered into a cooperative agreement to protect habitat and add public and educational opportunities on nearly 785 privately-owned acres of prime wetland habitat in St. Charles County previously known as the Whistling Wings Duck Club. The Missouri Conservation Commission formally recognized the new partnership at its Feb. 7 open meeting in Jefferson City.

The property lies just outside of St. Louis within the Confluence Region, an area recognized by the North American Waterfowl Management Plan as a priority Waterfowl Conservation Region. This is an important "Conservation Opportunity Area" and is specifically identified in Missouri's Comprehensive Wildlife Strategy as an area in need of conservation. The property is a mix of natural and agricultural habitats and holds a 330-acre refuge which is a significant migratory stopover for ducks, geese, and shorebirds during spring and fall migrations.

The former private duck club was recently acquired by GRHA from Ducks Unlimited. GRHA will own and operate the property for the purpose to forever protect, preserve and conserve the agricultural and natural areas for significant public benefit. The property will serve as GRHA's new headquarters and be a center for education, scientific research programs, land-management workshops, and managed public -hunting opportunities. The headquarters will be named the Jay and Carolyn Henges Wetland Education and Conservation Center in honor of the Henges Foundation financial support to GRHA. Jay Henges also served as a Conservation Commissioner from 1987 to 1993.

"We are thrilled about the creation of a conservation and education partnership with MDC and our shared vision to protect and conserve the property for generations to come." said GRHA President David Bub. "We look forward to developing public-use programs that align with GRHA, and MDC's mission including conservation demonstration, education, research, and hunting. Hunting programs will focus on recruiting new hunters, youth, veterans, women, educators, and first responders."

The cooperative agreement includes \$2 million in financial support from MDC to GRHA to help with acquisition of the property and to maintain critical wetland and waterfowl habitat on the area. These funds will also support mentored hunting opportunities for new hunters, veterans, youth, and others. The property will not be a part of MDC's managed waterfowl hunt program.

"The Missouri Department of Conservation is excited about our new partnership with the Great Rivers Habitat Alliance and the new opportunities we will have to provide high-quality mentored hunting on the property," said MDC Director Jason Sumners. "MDC staff will also be able to use the property to offer educational programs and habitat workshops."

GRHA was founded in 2000 to protect the confluence 100-year floodplain of the Missouri and Mississippi rivers through policy, protection, conservation, public awareness and education. GRHA collaborates with partners such as MDC to restore wetlands and to protect their conservation, flood storage, and habitat values in perpetuity by teaming up with farmers, duck clubs, and other land stewards to protect

land and land-use practices important to wildlife, waterfowl, and people. Learn more at grha.org/.

What is IFOR?

MISSION STATEMENT

To unite all outdoor resource user groups and conservationists (ex. hunters, fishermen, trappers, trail riders, etc.), dedicated to preserving, restoring and developing the State's natural resources, and to provide a professional liaison to the Illinois Legislature and the Illinois Department of Natural Resources (IDNR), to protect sportsmen's rights and recreational opportunities; and to work together to ensure longterm, adequate dedicated funding for, and professional management of the IDNR.

IFOR is a not-for-profit 501 C (4) Conservation Organization whose main purpose is to unite Illinois Outdoorsmen under one statewide umbrella and protect and defend the recreational rights of natural resource users in the state of Illinois. Currently we have united over 100 conservation groups and in excess of 76,000 outdoorsmen as members of IFOR.

This is exactly what we need here in Missouri. Granted, after chatting a bit with Tony, CFM does this similarly, however, if we have another avenue to voice our opinions would be a great thing. More organizations and individuals under one voice to ensure our outdoor activities. be it hunting, fishing or any outdoor activity is to remain here currently and for the next generation. With the current polocies that MDC is doing now, it is more than important to get organized, in which case we might be too late, for example: River blinds taken away, even when it was totally against by hunters, MDC turned a blind ear. Columbia Bottoms, the once jewel of MDC looks like a slum and now this cooperative agreement with the Great Rivers Habitat Alliance.

We need a larger voice to be heard. Not just single individuals or group voicing concerns to MDC and Jefferson City and this could be the answer.

EMPEROR GOOSE

Looking for some articles for filler came across this one from Delta. Do not know if we have too many trophy hunters but this one might be of interest if you are:

USFWS and State of Alaska to Close Hunting of Emperor Geese

Federal regulations reopened hunting of the species in 2017, but a decline in population signals closure per the current management plan

Federal, state, and regional wild-life managers have recommended that the emperor goose hunting season in Alaska be closed for both subsistence and sport hunting in the 2025 season. The most recent survey information recorded a single-year population index of approximately 19,000—well below the 23,000-threshold set by the Pacific Flyway Council's management plan to allow hunting.

Emperor geese, known for their striking white heads, gray bodies, orange feet, and two-tone pink and gray beaks, breed primarily on the Yukon-Kuskokwim Delta in western Alaska. Unlike many waterfowl species, they generally remain in Alaska yearround, wintering along coastal areas like Kodiak and the Aleutian Islands.

Federal regulations reopened the emperor goose hunting season in 2017, allowing Alaska an annual harvest of up to 1,000 birds for the fall-winter hunt under liberal regulations or 500 under restrictive regulations. Harvest is managed through a registration permit system across seven hunt areas, each with an individual quota. A total of 25 non-resident drawing permits

were available to non-residents per year.

"Like any wild population, many factors affect the population growth, decline, or stability," said Julian Fischer, a supervisory wildlife biologist with the U.S. Fish and Wildlife Service. "For emperor geese, which are slow to mature and reproduce, adult birds are critical to population stability." He explained that harvesting adults, along with habitat changes, food availability, and potential pathogens, are all possible contributors to the recent decline.

Fischer also emphasized the unique challenges of managing this species, explaining that with a small, remote population like emperor geese which are entirely reliant on natural habitats, significant events like storms or disease outbreaks can have outsized impacts. Predators, such as Arctic and red foxes, may also play a role in population changes.

Jason Schamber, waterfowl program coordinator for the Alaska Department of Fish and Game, emphasized that these factors are taken into consideration when reevaluating the species' management plan, which happens every three years.

"We're currently in the process of revising the Pacific Flyway Management Plan and the Alaska Migratory Bird Co-Management Council is responsible for managing the subsistence harvest in the state. So, both of those plans are open to revision currently," he said.

The proposed rule to implement the closure will be available to the public soon, where public input will be welcomed and later considered in the final rule.
