SELFISH ACT

I have been writing on Widgeon on or off now for about over a year and need to draw his story to a close. I have not been looking forward to this part of his story and have been doing a lot of thinking on how to approach it. Widgeon was not a stellar waterfowl dog but was a wonderful companion, we enjoyed many a hunt together throughout his years, retrieved numerous ducks for me, had lots of laughs together and lots of frustrating times together (never could get him from breaking) and he is the only dog that I ever trained.

Have you ever had to put an animal down? A good friend of mine asked me for advice on this and I basically advised him of a couple of things. One, the decision to put an animal down might be taken out of your hands and the good Lord will take the animal in it's sleep or it will be killed by some tragic incident. In which case, this is what all owners kind of hope for so we do not have to make this gut wrenching decision. Second, the animal will tell you when it is time to let them go. The animal is in pain, cannot walk or any other millions of reasons why it is trying to tell you it is time to let go. It is the one time that you cannot be selfish and to do the right thing, the last loving thing you can do for this member of your family that you have seen grow up, train and live with, is to put it out of its misery.

Widgeon's cysts came back with a vengeance. He was 14 at this time of his life. One on his right hip was the size of a paper plate and was impacting his walking abilities. Other than these cysts all over his body he was a happy, healthy dog. With his age, I knew it would be questionable to have the surgery, so I figured Widgeon would tell me, so I took him to the Vet to get his opinion. He was very cautious or wary about operating on such an old dog and wanted to take some blood work to see how his internal organs were to see it they could handle an operation. Widgeon was very excited, as per the norm, to the point when we went into the examination room he was beginning to hyperventilate. Then all of a sudden he had extreme difficulty in breathing, his lips began to turn blue and I could tell in his loving brown eyes he was screaming at me wondering what was going on and he needed help. I did not hesitate and immediately told the Vet to

put him down, which he did. The shock was immense. The Vet later told me that on Labs, or I guess on any dog, when they get old their esophagus hardens and can collapse in their throats creating a blockage and the animal suffocates to death, which is exactly what was happening to Widgeon if the Vet did not put him down.

After his death I had him cremated, he sits on our mantel over our fireplace. It is probably time to let him go. But I am being selfish and don't want to. He was such a good boy and a very important part of my life and family. He will be greatly missed.

MAY MEMBERS MEET-ING

If you missed Dr. Brian Reiter very informative talk about taking care of your waterfowl dog you missed a great opportunity to ask a fellow waterfowler what you need to look for in regards to your dog.

Some of the things to bring out that he mentioned if you have a waterfowl dog.

- A Vet needs to know your dog is a waterfowl dog, it will lead the Vet to the correct treatment and shots the dog needs.
- Bordetella vaccine or Kennel Cough vaccine is not just for dogs going into the kennel but for dogs who get around other dogs.
- Is your dog constantly licking their feet or get ear infections? You might want your Vet to look into allergies and the Vet might recommend Apoquel which is an allergy vaccination.
- Hepatitis vaccination. Granted, your dog gets this vaccination when they are about six weeks old but your dog is swimming in some of the most awful water imaginable and might need boosters, your Vet should know this.
- First Aid kit. One thing he brought up to me which was interesting was wound treatment. In the case of lacerations, in your first aid kit you

should have at least two items for lacerations. One, some sort of wound cleaning solution to get all the dirt and bacteria out of the wound and two, a wound stapler to close the laceration, which you can get from Amazon for under \$10.

 One thing he did state was to not put any triple anti bacteria ointment on the wound, just kep it clean and let nature take its course. A dog will lick off the ointment and it could be harmful to the animal.

COLUMBIA BOTTOMS

MDC recently bought 100 plus acres adjacent to Columbia Bottoms. With the advent of Columbia Bottoms being taken off of the managed waterfowl areas and being turned over to an open waterfowling area we were wondering why this occurred and the costs, after all, this is your tax dollars at work. Tony Wolf put in a freedom of information request to MDC regarding this purchase and after a long time of messages from MDC stating they are working on it finnally got a response which is below, along with the request:

The Missouri Department of Conservation received a public records request from you on March 25, 2024. Your request mentioned:

According to Gateway Greenway, they have said the 100 plus acres adjacent to Columbia Bottom has been purchased by MDC.

Please provide purchase price, fees, and all agreements that are part of the sale such as right of ways for future trails, etc granted to seller.

The Missouri Department of Conservation has reviewed its files and have located the information you requested. Please see below.

Purchase price - \$695,000.00

Closing fees - \$1,304.12

There were no agreements between the parties regarding future use of the property.

DOGS

New Regs for Bringing Dogs Into the US Set to Begin August 1, 2024

The U.S. Centers for Disease Control and Prevention has implemented new restrictions on bringing dogs into the United States that will impact hunters traveling with their duck dogs even between Canada and the United States. The new restrictions also prohibit the importation of any dogs younger than six months of age.

For hunters traveling outside of the United States with their dogs, the biggest change is that having an implanted microchip is no longer optional. It is mandatory. The chip must have been implanted prior to any required rabies vaccination, and the matching chip number must be documented on all required forms and veterinary records.

Additional paperwork is also required in completion of a "CDC

Dog Import Form." It is preferred that this document be completed online 2-10 days prior to crossing the border into the States, but it can even be completed as late as while standing in line at the U.S. Customs station, as long as there is a viable internet connection.

This new form also requires the attachment of a clear photograph of the dog showing its face and body. For dogs less than one year of age, the photomust have been taken within 10 days prior to the border crossing.

So far, the new requirements apply only to bringing dogs into the United States; however, there is a possibility that Canada (or other countries) may create requirements that mirror the CDC's. The most likely possible snare for any hunters caught unaware of the new regulations this fall is that you could take your dog out of the country without any problem but then run into serious legal issues trying to bring the same dog back into the United States.

Especially troubling is that the restrictions entirely prohibit the importation of dogs less than six months of age. This could pose complications for breeders and buyers of retrievers purchased for import from Great Britain and elsewhere in Europe.

Delta Waterfowl's chief policy officer John Devney said, "We are working with the AKC and other organizations to get our hands around these new regulations. We're joining together to

determine what might be done to modify the requirements to make them less onerous on dogs crossing the border for hunting, competition, training, and other legitimate purposes. We recognize that the intent of the CDC is justified in trying to manage some bad actors importing dogs into the country, but the unintended consequence ensnares a bunch of healthy working dogs—our duck dogs—in an overburdensome process."

1 pintail,2 scaup for first 45 days and 1 scaup for last 15 days,1 mottled duck

Possession Limit: Three times the daily bag or 18 total, varies by species

Snow Geese (White and Blue Phases) and Ross's Geese

Season: Nov. 11 through Feb. 6, 2025

Limits: 20 blue, snow, or Ross's geese daily with no possession limit

White-Fronted Geese

Season: Nov. 11 through Feb. 6, 2025

Limits: 2 daily and 6 in possession

Canada Geese and Brant

Season: Oct. 5-13 and Nov. 11 – Feb. 6, 2025

Limits: 3 Canada geese and Brant in aggregate daily, 9 in possession

Light Goose Conservation Order

Season: Feb. 7 through April 30, 2025

Limits: No daily or possession limits

Hours: One-half hour before sunrise to one-half hour after sunset

YOUTH HUNTING DAYS

North Zone: Oct. 26 and 27 Middle Zone: Oct. 26 and 27 South Zone: Nov. 23 and 24

Limits: Same as during regular waterfowl season

Hours: Same as during regular waterfowl season
